Circular Letter No. AC-II-1465-97 May 8, 1997

## TO ALL NON-RESIDENT BROKERS

Subject: Renewal of licenses for fiscal year 1997-98

Sirs:

Section 7.010 of the Insurance Code of Puerto Rico establishes as a condition to continue to be authorized to solicit or transact any kind of insurance in Puerto Rico, that the persons or entities so authorized shall pay, not later than June 30th of each year, a single annual contribution.

Considering the above, and in accordance with Sections 7.010(1)(r) of the aforesaid Code, the annual contribution to be paid by each non-resident broker shall be \$800.00. To this effect, and in order that said license be renewed as of July 1, 1997, it is necessary that the enclosed form be completed and sent to our Office before May 24, 1997, together with a check or money order for the aforementioned amount, payable to the Secretary of Treasury, and a pre-addressed small (12" x 9") manila paper envelope.

Nonresident brokers must also submit proof that the corresponding guarantee bond has been renewed. A certificate of extension of the existing bond will be sufficient.

The amount of the guarantee bond shall be determined according to the following scale, on the basis of the volume of business transacted by the non-resident broker for calendar year 1996, as per the Business Report filed with this Office for that year:

(787) 722-8686, Fax (787) 722-4400 The amount of the bond corresponding to the above scale shall be multiplied by the number of persons named in the license of the corporation of partnership, as provided in Section 9.200 of the Insurance Code of Puerto Rico.

Please be advised that all requests received after June 30, 1997, will not be considered for renewal by this Office. In said case, the applicant will be subject to all the formalities of the application process for a new license pursuant to the Insurance Code of Puerto Rico.

Strict compliance with the provisions of this circular letter is hereby required.
